# Animal Costume Contest

1. Contestants must decorate their animal in costume and be dressed to complement the animal's costume. Must have a theme for the entry.
2. Contest open to exhibitors 18 years old and younger. Animal must have been exhibited at this year's Fair. Age divisions will be 7 years and under; 8 years to 13 years; and 14 to 18 years. Animal classes will be Goats/Sheep; Pigs; Dairy/Beef; Horse and Rabbits/Poultry.
3. Contestant must complete Costume entry card.
4. May enter as an individual or team.
5. Nothing harmful to the animal may be used. If judge/officials determine a potential harm to the animal the entry will be disqualified.
6. Registration due by midnight on Thursday of fair week. Emma Wilson is accepting registrations for the 2026 contest. (Late entries not guaranteed a prize.)
